Terms and conditions:

- 1. The sealed tenders in a letter pad in prescribed proforma should be super scribed as "Tender for Supply of Chemicals, Reagents, Diagnostic kits, Discs and Glass wares etc." are to be submitted in the office of the undersigned on or before twenty one days from the date of publication through Regd. Post / Speed Post/Courier and the tender will be opened on the last date of submission at 5 P.M onwards in the office chamber of the undersigned and it may be extended. The tenders received beyond the scheduled date and time will not be considered under any circumstances.
- 2. The Tenderer should furnish the Earnest Money Deposit (EMD) of Rs.50,000/- (Refundable)(Rupees fifty thousand) only in shape of Bank draft in favour of the Dean & Principal, M.K.C.G. Medical College Hospital, Berhampur payable at SBI, MCC. Branch, Berhampur (GM). The E.M.D will be forfeited, in case the successful tenderer fails to execute the order within the stipulated period.
- 3. The tenderer should submit the EMD and tender document fees in technical bid.
- 4. The tenders received after due date and time will not be considered under any circumstances and The price bid will be opened whose tender will be qualified in the technical bid.
- 5. The tenderers or their authorized representatives may attend on the date / time of opening of tenders. If any tenderer or their authorized representatives fails to turn up at the time of opening of the tenders, the process will continue as usual.
- 6. - 12. The tenderer should submit up to date printed price list of products after selection of the respective brands.
- 13. The tenderer should furnish up-to date Photostat copies of the Valid GST certificate as per Govt. rule, valid PAN Card, valid ISI/ISO/GMP certificate, Valid Drug Licenses, Valid manufacturing license/Authorization certificate, for the items.
- 14. The tender will be valid for three years from the date of approval / may be extended with the same terms & condition subject to satisfactory performance/till finalization of next tender.
- 15. All legal disputes, if any relating to purchase etc. are subject to jurisdiction in the courts of law situated at Berhampur, Ganjam, Orissa.
- 16. The Dean & principal, M.K.C.G. Medical College Hospital, Berhampur reserves right to accept/ reject/ cancel any or all the tenders in full or part without assigning any reason thereof.

- 19. The payment will be released only after clearance certificate received from concerned HODs.
- 20. The tender documents should be clearly written/ typed without any corrections, interpolation and over-writings etc and each page of the tender should bear the dated signature of the tenderer.
- 21. The quoted rates should be in Indian Currency, both in words and figures against each items.
- 22. The price quoted should be final and shall not be subject to any escalation during the validity of the tender.


