The applicants should submit their proposal in the prescribed format along with all the supporting documents in a sealed envelope (technical bid & price bid separately) to the office of the DEAN & PRINCIPAL, MKCG MEDICAL COLLEGE, BERHAMPUR (SUPERSCRIBED 'TENDER FOR LEASE CANTEEN'') by 28-11-2023 till 05:00 pm through Registered Post/ Speed Post/courier service only. The technical bid will be opened on 28-11-2023 at 05.30 P.M in Telemedicine conference hall of MKCG in the presence of the bidders Details may be obtained from the website i.e www.mkcgmch.org.

TERM & CONDITIONS

- 1. The Tender cost of Rs.2000/-+ GST is non refundable to be paid by way of Echallan under head of Account 0075-00-800-0097-02237-000 through Odisha Govt. Treasury site.
- 2. The canteen building will be provided by the MKCG Medical College, Hospital, Berhampur in Campus.
- 3. The minimum offset price is fixed for Rs.10,000/- per month
- 4. The highest bidder will be selected to award the contract
- 5. The contract will be for one year and extendable for a maximum period of three years subject to satisfactory performance and regular payment of monthly charges.
- 6. The tenderer quoting less than 10000/- will be out rightly rejected.
- 7. The offer along with related documents should reach the undersigned in sealed envelope on or before 28-11-2023 at 5 P.M. positively which shall be opened on 28-11-2023 at 5.30 pm in presence of all the bidders or their authorized agents.
- 8. EMD: The bidder has to submit EMD of Rs.5,000/- in shape of DD in favour of the Dean & Principal MKCG MC Berhampur.
- 9. The DD towards EMD is to be deposited with Technical bid.
- 10. Technical bid without DD shall be rejected.
- 11. At the time of opening of tender the bidders will have to produce the original documents for verification.
- 12. An agreement will be executed between the Dean & Principal & the approved agency for running the Canteen.
- 13. The list of food items required for the students & staff is at Annexure-A
- 14. The rate of the items will be decided by the members of the subcommittee.
- 15. Supply of substandard food will liable to be rejected and agreement will be cancelled instantly.
- 16. The successful bidder has to deposit the performance security of Rs.50,000/- in shape of bank Guarantee in favour of the Dean & Principal MKCG MCB. This will be forfeited if the terms & conditions of agreement is violated.
- 17. The monthly amount will be deposited in the account of Dean & Principal MKCG MCH in No.149701000826 IFSC.ICIC0001497 by $1^{\rm st}$ week of every month otherwise the service will be terminated.
- 18. The Hospital authorities shall have the right to inspect at any time and issue directives, which are in conformities with agreements and the contacting agencies, should comply with directives
- 19. The performance security will be forfeited in case of default in service as per agreement executed.
- 20. The EMD of successful bidder will be forefeited if the agreement is not executed.

- 21. The agreement will be extended after deposit of performance security.
- 22. The successful bidder has to submit the police verification certificate of the proprietor/individual & the staff to be engaged from the local police station. There should not be any criminal record of the persons to be engaged in the canteen.
- 23. The valid food license is required.
- 24. The successful bidder/ awardee will be held responsible for any mischief occurred in the canteen.
- 25. A separate meter for electricity will have to install by the awardee.
- 26. Cleanliness & hygiene is to be maintained strictly inside the canteen premises & the cooking area also. Any deviation found during the visit of the food committee than it will be liable to cancel the agreement. Subsequently the canteen must be vacated within 15 days from the date of issue of Notice.
- 27.An affidavit is to be submitted for non-blacklisting by any organization & also no criminal procedures against the firm or proprietor or against the company/agency.
- 28. The authority reserves every right to modify any term and condition/accept or reject any tender without assigning any reason thereof.
