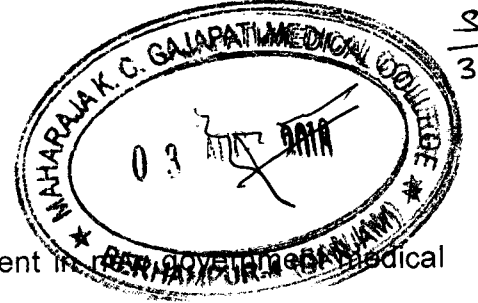

Sub:- Engagement of Senior Resident/ Tutor/ Junior Resident in new government medical colleges and MKCG MCH, Berhampur

Sir,

In inviting a reference to this department Letter No. 27131/H dtd. 22.12.2016, No. 23826/H dtd. 16.09.2017 and no. 25125/H dtd. 09.10.2017, I am directed to request you to fill up the gaps in the posts of Senior Resident/ Tutor/ Junior Resident in new government medical colleges and MKCG MCH, Berhampur by floating centralised advertisement in the website of O/o DMET(O) after ascertaining the vacancies from the concerned medical colleges with the following terms and conditions.

1. The candidates applying for the posts may be directed to give their choice of placement chronologically in the prescribed proforma designed by o/o DMET and the choice so exercised once should not be changed.
2. The eligibility of SR/Tutor may be as prescribed in this Department Letter no. 25125/H dtd. 09.10.2017.
3. The age of the candidate shall be as per the extant MCI norms.
4. The appointment/engagement shall be purely temporary and on year to year tenure basis and shall be for a maximum period of three years subject to satisfactory performance.
5. Performance appraisal certificate is to be prepared by the Professor/HOD of the concerned Departments countersigned by Dean & Principal of respective colleges for renewal/ extension of their further continuance in the tenure post by the DMET. During the tenure period and upon receipt of any unsatisfactory performance report at any point of time from the concerned Professor/ HOD, the services of the concerned SR/ Tutor will be terminated by the appointing authority, ie., DMET.
6. The appointing authority can terminate the tenure of SR/ Tutor by serving a notice of 30 days.
7. Teaching experience of SR/Tutor shall be reckoned from the date of joining in such post and the period of leave availed by SR/ Tutor will be compensated by repetition.
8. In no case, transfer from one institution to another will be allowed.

9. Applications of those SR/ Tutors who are continuing/ completed the tenure in any MCI recognised institution will not be considered for selection.

10. A panel of SR/ Tutor may be prepared by the office of the DMET which will remain valid for a period of one year from the date of its approval.

11. Appointment/ engagement orders to be issued by the DMET under intimation to this Department.

Besides these, other conditions as deemed proper may be incorporated by DMET(O) under intimation to this Department.


Similarly, the vacant posts of Junior Residents may also be filled up in the new medical colleges as per the sanctioned strength and MCI requirement as per the earlier practice till they are filled up from regular OMHS Cadre.

The entire process is to be completed in 10 days.

In case Director, VIMSAR gives a requisition for filling up of such posts of VIMSAR, Burla, the same may also be taken up.

This may kindly be treated as most urgent in view of MCI inspection.
