FILLING UP OF VACANT POSTS OF JUNIOR RESIDENTSAT M.K.C.G. MEDICAL COLLEGE & HOSPITAL, BRAHMAPUR.

Applications are invited from the eligible candidates for the posts Junior Residents (JR) in different disciplines at M.K.C.G. Medical College & Hospital, Brahmapur. The applicant must have acquired the required qualification for the post applied for on or before the date of counseling. The engagement shall be purely temporary on a year-to-year tenure basis and may be for a maximum period of three years subject to satisfactory performance. The posts are purely non-practicing. The direct candidates will be paid a consolidated amount of Rs. 55, 000/- (Rupees Fifty five Thousand only) per month. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. Eligibility of application will be guided as per the provisions mentioned here under:

The vacancy shown is provisional and is subject to change as on the date of counselling. Vacancies occurring after the date of counselling shall be filled up through fresh advertisement. A panel list of JRs will be prepared by the committee on the basis of merit which will remain valid a period of one year from the date of its publication. In case any vacancy arises in the vacancy list notified in the advertisement it shall be filled up from the panel list.

A. ELIGIBILITY:

- a. The candidate must be a citizen of India.
- b. Age limit: Must be less than 65 years of age on dt.01-07-2022.
- c. Reservation: Vacancy based reservation will be applicable as per the guidelines of Govt.
- d. Qualification:
 - i. For the post of Junior Residents the candidate must possess MBBS Degree [for Medical stream] & BDS [for Dental stream] or any Equivalent Degree in concerned discipline applied for or as prescribed by MCI /NMC/ DCI in "Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998" notified or amended from time to time in force.
 - ii. Must have registered himself/ herself [permanent registration only] under any State Medical Council/ MCI after obtaining the degree.
 - iii. The above qualifications must have been obtained on or before 01-07-2022.
 - N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council shall only be accepted.
- e. Candidates who are continuing as Junior Resident in any MCI / NMC/DCI permitted [approved/recognized institute are not eligible to apply.
- f. Candidates who are serving under OMHS cadre on regular basis are not eligible to apply.

B. PROCEDURE OF APPLICATION:

- a. Candidates are required to submit their application addressed to the Dean & Principal, M.K.C.G. Medical College & Hospital, Brahmapur -760004, Odisha in the prescribed form along with other particulars/documents. The Application Form and guidelines can be obtainable from the M.K.C.G. Medical College website: www.mkcgmch.org.
- b. Candidates are required to send their application by Registered Post/Speed Post only so as to reach in the Office of the Dean & Principal, M.K.C.G. Medical College, Brahmapur 760004, Odisha on or before i.e. 06-08-2022, the last date of receipt of application. The envelope containing only one application must be super-scribed "Application for the post of Junior Resident."

- c. E-applications shall not be accepted.
- d. Applications received after the due date and time will not be accepted/entertained under any circumstances.
- e. In-service Candidates other than OMHS cadre has to submit the permission from the cadre controlling authority.
- f. Application fee: A candidate is required to pay a non-refundable and non-adjustable fee of **Rs.500/-(Rupees Five hundred)** only through online mode at https://www.onlinesbi.com/sbicollect/icollecthome.htm [under Odisha/ Educational Institute /MKCG Medical College, Berhampur / Recruitment fee], Berhampur towards application processing fee. The above fee is for one application only.

C. METHOD OF SELECTION:

- a. Reservation Policy: Vacancy based reservation will be applicable as per the guidelines of Government.
- b. Selection will be made by a Selection Committee.
- c. Selection shall be on the basis of the marks secured i.e. 20% of HSC marks, 20% of +2Science marks (excluding 4th optional/extra optional marks) and 60% of all MBBS marks.
- d. In case of foreign medical graduates (FMG) the marks secured in the subjects as per the NMC/MCI conducted by NBE shall be taken for calculation of merit as above.
- e. Where the candidate does not submit such mark sheet, application will be rejected.
- f. One mark will be deducted from the total career marks for each extra attempt taken to pass the examination.
- g. If two or more candidates secure equal marks then the candidate securing higher marks in MBBS examination shall be placed in higher rank in the merit list. Further, the candidate older in age shall be placed above the younger.
- h. After scrutiny of the documents, a provisional merit list will be prepared and published in the college website inviting objection if any in the merit list. The objection can be submitted only through e-mail in [principal.mkcgmc@gov.in]. The grievances if any will be examined and a final merit list will be notified. A spot counselling and document verification shall be conducted before appointment. The date of verification of certificate and counseling will be published in the website of the college i.e. www.mkcgmch.org. The final merit list prepared after counseling will remain valid for a period of one year or till subsequent advertisement whichever is earlier
 - N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her.
- i. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.
- j. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- k. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject will be given a chance.
- l. All communication shall be made through the website of MKCG MCH, Brahmapur i.e. www.mkcgmch.org. No Postal/Personal communication will be made.
- m. Engagement will be on the basis of merit and choice. Appointment/Engagement order shall be uploaded in the website of MKCG MCH, Brahmapur, i.e. www.mkcgmch.org. The direct candidates must join within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from the Government.

- b. The in- service candidates will be entitled to draw their usual salary and the direct candidates will be paid consolidated amount of Rs. 55, 000/- (Rupees Fifty five Thousand only) per month. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable.
- For contractual direct candidates, the engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one-month prior notice from either side.
