The age relaxation for the applied post in respect of the employee of the OHS&FW Society shall be allowed @ 1 year for each contractual term of service in the society up to a maximum of 10 years, over and above the maximum age limit prescribed in the Advertisement for the said post, subject to an upper age ceiling of 55 years.
