Resolution No.18582/H Dt. 13-08-2020.

The In-service Medical Officers will carry their pay alongwith Grade Pay and Direct category candidates shall be entitled to a fixed remuneration of Rs.65,000/- (Rupees Sixty five

thousand) only per month or as would be decided by the Government from time to time.

- 1. The engagement is purely **temporary** and is for a period of **one year only**.
- The engagement is terminable at any time with one month notice by either side without assigning any reason thereof. It will be open to the Government to pay in lieu of one month's notice, pay for the period by which the notice falls short of one month and viceversa.
- 3. On appointment he / she will be posted at different places under the same speciality including Casualty as per the orders of the competent authority, from time to time. Further, he will be posted any where depending upon the emergent needs of the State in the public interest.
- 4. As soon as the Medical Officer completes the Senior Resident-ship / Tutorship, he / she will return to join the periphery service. The concerned Dean & Principal and Superintendent will submit proposals to Govt. for their posting in the periphery service at least one month before the exact date of completion of the Tutorship / Resident-ship.
- 5. In case of discontinuance of Tutorship / Resident-ship of a particular candidate, the Dean & Principal / Superintendent will give the NOC and NDC for his further posting in the periphery.
- 6. Before the engagement he / she will execute a bond on non-judicial stamp paper worth Rs.100 before the institution head that he / she will not indulge in any kind of private practice / litigation / resort to strike / cease of work / bargain with Govt. for his / her continuance beyond permissible period. He / She will also undertake to join at the place of posting as soon as his / her Senior Resident-ship / Tutorship is completed or he / she receive Government Order for the same. In case of violation of these provisions he / she will not be given the completion certificate.
- 7. The direct candidates are to submit the following documents at the time of their joining.
 - i. Two Character Certificates from two Gazetted Officers.
 - ii. Physical Fitness Certificate from a Medical Officer not below the rank of Assistant Surgeon working under the Sate Government.
 - iii. Marriage Declaration / Non-contact of plural marriage.
 - iv. Two recent passport size coloured photograph.
 - v. An Oath of allegiance to the Constitution of India.
 - vi. Personal Management Information Sheet.
 - vii. Attestation form in duplicate duly filled in.
 - viii. Caste Certificate (in case, belongs to SC / ST / SEBC).
- 8. At the time of joining the institution, the in-service candidates are required to submit relief order from the concerned authority under whom he / she was last working.
- 9. He / She is required to perform the duties as per the job chart and as would be prescribed by Government from time to time.

He / She should join his / her new assignment by 03-12-2022 positively, failing which the appointment / engagement will automatically stand cancelled.
