



Sub: *Relieve of In-Service Medical Officers of OMHS Cadre and Dental Surgeons of OMS (Dental) Cadre for prosecuting PG / DNB Course during the academic session 2023-24.*

Sir,

In inviting reference to the above mentioned subject, I am directed to say that, the counselling for admission to PG study under All India Quota / State Quota has already been started for the academic session 2023-24. Accordingly, the regular in-service Medical Officers of OMHS Cadre and Dental Surgeons of OMS (Dental) Cadre selected for the purpose are to be relieved from their duties so as to enable them to join the course in the allotted Institutes as per the scheduled date.

2. To enable the selected candidates to join the course in the allotted Institutes in time, it is requested to relieve the regular in-service Medical Officers of OMHS Cadre and Dental Surgeons of OMS (Dental) Cadre working under your administrative control who are not on unauthorised absence / long leave on production of their Allotment / Admission letter issued by the concerned Counselling Authorities on the following conditions.

(a) The Medical Officer/Dental Surgeon will pursue the course at his/her own cost availing leave due and as admissible to him/her.

(b) The Medical Officer/ Dental Surgeon will give an undertaking (in shape of an affidavit) to the DHS, Odisha through the concerned authority to the effect that he/ she will join in this Department soon after completion of the course failing which Disciplinary Proceedings shall be drawn against him/ her.

3. Medical Officers/Dental Surgeons remaining absent unauthorisedly / long leave shall not be relieved without approval of the Government.

4. No Medical Officer / Dental Surgeon shall be relieved for any **sponsored course**.

5. The Adhoc and Contractual doctors shall have to resign from the service for prosecuting higher study.
