I am directed to state that the Central Govt. has recently modified the teacher student ratio from 1:1 to 1:2 by amending the Postgraduate Medical Education Regulations, 2000. Accordingly, the Health Secretaries of all the States were requested by MCI to direct the Deans/Principals of Govt. Medical Colleges in their respective States to send the information with regard to availability of Professors in the subjects of broad specialities and availability of Professors & Associate Professors in respect of Super-specialities and also Unit wise number of teaching beds & students. The information received from your college was considered by the Postgraduate Committee of Medical Council of India at its meeting held on 15.12.2009 in the light of Gazette Notification dated 24.7.2009 and recommended to this Ministry to issue letter of permission for enhancement of seats in various postgraduate courses.


