"The Board of Governors considered the Council Assessor's Report (24.06.2020) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MD(General Medicine) qualification for 15 (12 & 12 to 15) seats granted by Berhampur University in respect of students being trained at MKCG Medical College, Berhampur be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
