## Berhampur University - Recognition of DM(Cardiology) qualification for 02 seats in respect of Subject: students being trained at MKCG Medical College, Berhampur.

Sir/Madam,

I am directed to state that the Board of Governors considered the Assessment Report (06.08.2019) on the standard of examination and other teaching facilities available at MKCG Medical College, Berhampur for purpose of Recognition of DM(Cardiology) qualification for 02 seats granted by Berhampur University and decided as under: -

"The Board of Governors considered the Council Assessor's Report (06.08.2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that recognition of DM(Cardiology) qualification for 02 seats granted by Berhampur University in respect of students being trained at MKCG Medical College, Berhampur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
